**LA08/2024/0259/F - Installation and operation of a 29.9MW solar farm on lands south of Magheralin and southeast of Dollingstown**

Please see attached updated information to address concerns raised by Historic Environment Division – Historic Buildings (HED HB), in their consultation response dated 05<sup>th</sup> June 2025. The updated information can be summarised as an updated photomontage and associated updated landscape mitigation plans and corresponding Section drawing.

Please refer to the sub-headings below.

**Landscape Mitigation Plans**

For the avoidance of doubt, landscape updates are illustrated along the frontage of Springhill Road to reflect amendments proposed to address HED HB concerns, which comprise coniferous plantation along the northern roadside. This change has meant updates to two of the previously landscape mitigation drawings, 01 – Landscape Mitigation Plan (Overall) and 02 – Landscape Mitigation Plan (Sheet 1 of 5).

For completeness, the entire suite of landscape drawings are now resubmitted, which taking account of the updates are now numbered as follows:
